Access Authorization Level Description: Continuance of Release and Waiver

The below explains the various levels of access rules and regulations. All volunteers are expected to understand and comply with these rules. These rules are for your safety, the safety of our staff, and the safety of our animals.

Level 1A: Generally reserved for staff, board members, and select APAGC members.

- Full access to the facilities, animals, and premises in order to care for the animals. Typically, this group will have keyed access and are trained to handle and care for all animals.

Level 2A: Generally reserved for volunteers who are familiar with the facilities and volunteer monthly.

- Volunteer as needed for adoption days.
- Access to common areas within the facilities.
- Trained to enter animal pens to play, walk, and perform other volunteer duties as needed.
- Follow all signage rules.

Level 3A: Generally reserved for occasional volunteers or workers.

- Volunteer as needed for adoption days.
- Access to common areas only.
- Must sign-in when volunteering at the shelter.
- Must be escorted and/or guided to a location by a Level 1A or 2A while in the shelter.
